Dog Control Officer Tim Hart: Written Report

Kevin Zaumetzer: Highway

- 1. Kevin discussed the need for a new loader and gave options to lease or purchase.
- 2. Henry's Trail: Would like to see some new signs put up and possibly a picture of Henry on a sign.
- 3. I would also like to see a small parking lot up near the picnic area.
- 4, Essex County would like to take a surplus trailer that the Town of Jay doesn't use anymore. Motion made by Supervisor Depo, 2nd by Councilman McDonald to get a contract between the seller and the buyer. All in favor, none opposed, carried. Res. #51018-10
- 5, I talked with the owner of the Black Smith Shop in Jay. I asked if we could get an easement from him so that we can get the property repaired, Attorney Manning stated we would need an easement from the land owner, we will need to look into this situation.
- 6. We would like to take the back boards off the Grove Basketball area and take them to the Jay Playground. Attorney Manning stated due to FEMA, we can remove the items, but will not be allowed to use the area for a parking lot.

Motion made by Councilman Garcia, 2nd by Councilman McDonald to remove the Grove Basketball area and take the items not being used to the Jay Playground, All in favor, none opposed, carried. Res. 51018-11
